COMMENTS:

Bison is proposing a pad size increase (during construction) from 10.85 acres to 11.4 acres. Since the original planning and permitting of this location, several changes have been made related to stormwater management, and topsoil protection practices which have led to the need for this additional acreage.

Per the attached preliminary figure- the NE corner has been expanded to accommodate a "short term" topsoil pile, which will be utilized for interim reclamation. This allows us to more permanently stabilize the secondary "long term" topsoil pile. In addition, we have redesigned our ditches and sediment trap per good engineering practices.
