## COMMENTS:

Bison is proposing a pad size increase (during construction) from the permitted 10.4 acres to 10.85 acres. The existing pad is approximately 9.9 acres. Operator plans to drill the remaining wells in May 2021. Operator is proposing additional acreage in the NW and SE corners of pad. Several changes have been made related to stormwater management, and topsoil protection practices which have led to the need for this additional acreage. Our plan is to relocate and regrade the existing topsoil pile to a more manageable location along the NW side of pad.
