COMMENTS:

TEP Rock Mountain LLC (TEP) requests permission to tie the bradenhead into the separator downstream of the choke on the Hilton 16-312D well. A diagram for plumbing the bradenhead into the separator is attached. This well is located within the Mamm Creek Bradenhead Monitoring Area with a threshold pressure of 150 psi. The bradenhead will currently build to 283 psi if left shutin. This will allow the bradenhead pressure to equalize with our separator/line pressure which is currently ~90 psi and protect the integrity of the surface shoe.
