Various debris and fence equipment previously observed has been removed; utility pole and shed have been removed from pad and placed at the access road entrance- equipment pending removal. Access road not yet decompacted, recontoured and regraded. Revegetation activities not yet performed.

Work to address the corrective action in process; Corrective action from inspection #696202322 will remain applicable, and Location will remain out of compliance until reclamation work has been completed pursuant to COGCC 1004 Rules.
