A Form 10 Change of Operator document has been submitted for the NELSON 5-31 Well (API # 05-123-30721). The centralized facility is located at 40.34759, -104.90694 and is permitted separately alongside the NELSON 5-41 Well (Loc ID 419298). This site was accessed via a preexisting crop divide road off CR 50 which remains in place for its historic purpose then branched west into the well site. All portions of the access road specific to the NELSON 5-31 Well have been fully reclaimed and returned to cropland. Please see the attached report for additional reclamation activities, details on the completed vegetation assessment, and photo documentation.
