This centralized facility is permitted separately and served the REEMAN 12-5 Well (Loc ID 306217, API 05-123-24233) and the REEMAN 11-5 Well (Loc ID 306265, API 05-123-24325). This site was accessed via a preexisting crop divide road, which remains in place for its historic purpose. All portions of the disturbance, including the portion of the access road specific to the REEMAN 11-5,12-5 Facility, have been fully reclaimed and returned to cropland. Please see the attached report for additional reclamation activities, details on the completed vegetation assessment, and photo documentation.
