 Field Inspector Actions:
 On 3-23-2021, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Lynn Johns 8690 County Road 10 stated the issues were occurring outside of complainants home.
 On 3-23-2021, I attempted to make contact with the complainant who indicated that on 3-18-2021 experiencing a squealing sound from the pump unit to the north of complainants home. Noise usually occurs during nighttime hours.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, Pumping Unit was not running so I could not hear any noise. I spoke with KPK supervisor he stated he would look at timer and see if he can run it during day light hours and find source of noise. I time of inspection road was not assessable due to weather condition and no gravel on road. Inspector will be going out periodically to location to try to find source of noise.
 No violation of COGCC rules were observed at the time of the inspection.
