Response: FACTUAL REVIEW REQUEST

Basis for Review: Action requested was already completed prior to the inspection

Operator Comment: Comments provided by the inspector are not accurate and do not reflect actual CA's associated with Spill/Release ID 478005. CA's required in Insp Doc #690102098 were addresses with the submittal of Supplemental Form 19 Doc #402495172. Additional CA's related to Spill/Release ID 478005 were addressed with the submittal of Form 27 Doc #402537539. No soil samples have been collected from this location as excavation of impacted soils has yet to be completed.
Inspector inaccurately notes, "Per previous CA's Operator shall provide sample location diagram, summary table of analytical results compared to table 915-1 standards, analytical lab reports, disposal manifests and gate tickets, and documentation on the source/location and volume of the clean fill dirt imported on site via supplemental Form 19 no later than 45 days from the Spill Report Date (10/29/2020)." Table 915-1 standards were not applicable until the January 15, 2021 rule change effective date. Table 915-1 was never referenced in historical CA's associated with Spill/Release ID 478005.

COGCC Decision: **Not Approved**

COGCC Representative: Supplemental Form 19 Doc #402495172 addressed requirements in Insp Doc #690102098 regarding water well and surface water sampling. No additional documentation was provided in Form 27 Doc #402537539. Analytical data regarding soil sampling, as required by Corrective Action, has not been submitted to the COGCC. As Operator has not completed an environmental investigation prior to January 15, 2021 Operator is required to comply with Table 915-1.
