INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Form 19 #401091323 (8/10/2016): Approximately 201 bbls of rainwater filled the well cellar on location and mixed with approximately 0.57 bbls of oil. The resulting mixture migrated onto the pad surface where it was contained. The location was inspected for leaks of which none were found. Contained on working surface within the pad berm and vac truck used to recover 160.57 of bbls (rainwater/oil mix) of 201 bbls released rainwater.

Preliminary soil samples were collected on July 7, 2020 from the suspected impact area. A grab sample (analyzed for Table 910-1 analytical list) was collected from the suspected impact area at a depth of 0 to 6 inches below ground surface (ft-bgs). Results show elevated SAR and EC levels within the impacted area.
