#### COMMENTS:

On 03/03/2021, Colton conducted a bradenhead test as an alternative method to demonstrate mechanical integrity. The bradenhead test is filed on a Form 17, document number: 402621112. The Bradenhead on the McLennan State A-1 did not have enough pressure to register on a gauge, and when opened there was a very slight whisper to dead in less than 1 second. There are no fluids present at the open bradenhead valve. The tubing pressure during the test was 510 psi and the production casing pressure during the test was 680 psi. Neither pressure changed during the test. The stable pressure inside the wellbore and lack of pressure on the bradenhead is evidence that there is mechanical integrity of the wellbore and effectively demonstrates what an MIT would. The well is currently shut in, leasehold HBP and frequently monitored by the pumper for any changes that would indicate an issue with the wellbore.
