No	<u>BMP/COA Type</u>	<u>Description</u>
1	Storm Water/Erosion Control	During development activities, this location will be inspected every two weeks for storm water deficiencies and after post precipitation events. Any deficiencies identified are addressed in a timely manner by PDC's construction department.
2	Storm Water/Erosion Control	Storm water perimeter control on the Stugart State will be comprised of earthen dikes and swales, detention ponds, sediment traps, inlet/outlet protection, surface roughening and other structures designed to slow, filter and control storm water runoff. All BMPs installed align with the Urban Drainage Dictionary and are approved for use under PDC's CDPHE field wide permit.
3	Storm Water/Erosion Control	BMPs are engineered to capture storm water runoff, direct flow around the pad, allow sediment to settle, and slowly discharge away from the sensitive areas. These controls will be installed on all sides of the location and will protect off site HPH areas east of this location.
