TEP Rocky Mountain LLC (TEP) respectfully requests approval to find and repair a leak in the production casing of the Hilton 16-312D well per the following proposed procedure:

1. MIRU service unit, kill well.
2. NU BOP and test.
3. POOH 2-3/8" tubing.
4. RIH with 4-1/2" TSBP.
5. Set BP at ±3,800'.
6. Pull casing slips and lay down parted casing.
7. Manually backoff production casing below joint with leak.
8. POOH with casing and lay down.
9. RIH with new casing and screw back into existing casing.
10. Pressure test casing.
11. RIH and retrieve RBP. POOH.
12. RIH with production tubing. Land tubing at 7,518'.
13. RDMO service unit.
