Comment: **It was observed in this inspection that the Location is out of compliance with COGCC 1004 Rules; culvert at the Location entrance has not been removed; gravel from road and production areas has not been removed; areas where equipment was Located is bare; compaction concerns also observed on the former production areas and the access road; compaction alleviation does not appear to have been conducted in accordance with 1004 Rules.**

Corrective Action:	Comply with COGCC 1004 Rules including, but not limited to, removal of culvert, gravel, compaction alleviation (cross-ripping to a minimum depth of 18 inches) and revegetation activities. Ensure control measures are implemented to stabilize the seeded soils and that sufficient on-going weed management activities is conducted to keep Location free of species considered undesirable and noxious.
