While there, I observed normal production operations.

During this inspection the following possible compliance issues were observed:

1) Location lacks stabilization. See photo #3424 and #3425. No form of tracking control at entrance to location. See photo #3426 with a corrective action date of 4/23/21.

- Location is located in a high priority habitat area.
