Operator reported fire on tank battery in September 2020. Fire burned tires that rancher had placed near tank battery that is located on state land. Neither operator or surface lessee have attempted to clean up visible impacts left from tires burned from fire. See attached photos.

Since impacts resulted from fire at operators tank battery operator is responsible for cleanup on state lands. Operator shall immediately submit Form 27 Initial to Area EPS outlining cleanup and sampling plan. See corrective action.
