During this inspection the following possible compliance issues were observed:

- 1) Battery sign weathered and not legible. See photo #3446 with a corrective action date of 7/12/21.
- 2) Location lacks stabilization. See photo #3447 and #3448. No form of tracking control at entrance to location. See photo #3449 with a corrective action date of 4/24/21.

- Location is located on the edge of a high priority habitat area.
