INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

During lease operations, water was found to be surfacing along the gas processing line. Line was immediately shut in and a berm and booms were installed around leak area to minimize spill. Initial soil samples were collected to characterize surface spill impact. Additionally, a water sample was collected down gradient from spill area along Conn Creek. It is not anticipated that Conn Creek will be impacted with the release. Excavation of the area will be completed once the utilities are cleared. Additional information will be provided with the Supplemental Form 19.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

3 monitoring wells and 3 soil borings proposed. Soil borings depths and grab soil sampling locations will vary and rely on field screening (PID). Laramie does not expect to advanced drilling to depths past 50 feet below grade if impacts are not identified by field screening instruments. Depths of advancement will vary depending field conditions during drilling.

Proposed Groundwater Sampling

During delineation via drill rig. If groundwater is located, a well will be set and sampled accordingly for table 915. TBD - number of water wells and number of samples collected. Supplemental information will be provided in additional reports when made available. If groundwater is not encountered by 50' depth and field screening instruments do not identify soil impacts, the well will be set at 50 foot below grade and monitored quarterly for one year. It is expected to encounter ground water prior to 50 foot below grade.
