Attention Chris Binschus:

A Form 10 Change of Operator document has been submitted for the SCHWAB 26-12F Well (API # 05-123-15325). The centralized facility is located at 40.280812, -104.753624 and is permitted separately (Loc ID 471575). The facility served the SCHWAB # 26-13F (05-123-15266), SCHWAB # 26-12F (05-123-15325), CECIL K # 35-29 (05-123-25502), and CECIL K # 35-30 (05-123-25503) PA wells. The site was accessed via a preexisting crop maintenance road that branched south to the SCHWAB 26-12F Well. The crop maintenance road remains for its historic purpose; all portions of the access road specific to the SCHWAB 26-12F Well have been fully reclaimed and returned to cropland. Please see the attached report for additional reclamation activities, details on the completed vegetation assessment, and photo documentation.
