General Comment:

On 4/5/2021 COGCC Staff; Kris Neidel and Emily Waldron inspected the BigHole Fed 13-1, API #081-06242. Weather was part-cloudy, dry and 63 degrees. This inspection was a follow up to inspection dated 4/2/21. On 4/2/21, COGCC had observed an ongoing release from a failed section of Process Piping. (see 4/2/21 inspection doc # 689805578). On 4/5/21, the following was observed: area of saturated and stained soil at spill point (west side of tank battery, aprox 35ftx35ft), elevated pipe racks coming out of tank battery appeared to have had non-consolidated soil piled on, the spill path, areas of the spill path had been scraped with a skidsteer (or similar), Areas of stained soil were observed and are shown in attached photos. Corrective Actions: Provide final disposition for soils that were scraped from spill area. Remove any remaining soil staining immediately. Immediately file a Form 19 Spill Report, Delineate the horizontal and vertical extent of impacted area and remediate impacts to Table 915 standards.
