Pit has been previously backfilled. Well was plugged in 2009. COGCC was given 72 hours notice prior to sampling, but representatives were not present during sampling.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

On 5/15/18, Wexpro Company attempted to core sample the backfilled pit area (facility 116630) on the Sugarloaf Stateland 1 well pad, as per the previously approved core sampling plan. The location of the pit was determined using historic Google Earth imagery, site security and GPS coordinates. Several sample attempts were made to obtain a sample of the pit in the area believed to have been most impacted. Depths of the samples were determined by the extent that the auger could reach before hitting rock. Sample #1 was taken from the area that was shown on historic GE imagery (GPS'd), and sample #2 was taken from the area behind a visible showing of gravel, as the tanks on location would have been placed there and site security showed the pit behind the tanks. See attachments for sample information.
