<p>COGCC Inspection Report Summary</p> <p>On 4-14-2021 at approximately 2:34PM, I Randy Silver, conducted an inspection of KPK well</p> <p>API # 05-123- 08574 in Weld County Colorado.</p> <p>The purpose of this inspection was to confirm compliance with the COGCC Director's order under rule 901.a. of the Rules and Regulations of the Colorado Oil and Gas Conservation Commission, 2 CCR 404-1 ("Rule" or "Rules"). As part of this order the operator KPK (Operator No. 46290) was ordered to immediately suspend all production operations at these assigned location.</p> <p>I inspected this location and confirmed operations appeared to be suspended as equipment on site does appear to be shut off and valves appear to be closed.
