Operator Comments:

When reviewing Remediation Project Number 4811 located on the 1J location, Caerus identified a timeline of landfarming treatment activities found on the 1B (REM #4500) and 1J (REM #4501) well pad locations. Landfarming activities were proposed by the operator for REM # 4811 in December 2007, but was approved by the COGCC in 2009. Landfarming activities associated with REM #s 4500 and 4501 were conducted in July 2009 and closure was approved in September 2009. Given the timeframe for landfarming activities being conducted on the 1B and 1J well pads, Caerus believes Remediation Projects REM # 4811 and Rem 4501 were conducted at the same time, on the same location and therefore should be closed by the COGCC and a no further action determination should be assigned to the project.
