When reviewing Remediation Project Numbers 3908 and 3807 located on the 1B location, Caerus identified a timeline of landfarming treatment activities found on the 1B (REM #4500) and 1J (REM #4501) well pad locations. Landfarming activities were proposed by the operator for REM # 3908 in March 2007, but was approved by the COGCC in 2008. Landfarming activities associated with Spill # 1433564 and REM # 3807 were proposed in October 2006 and approved in November 2006. Landfarming activities associated with REM #s 4500 and 4501 were conducted in July 2009 and closure was approved in September 2009. Given the timeframe for landfarming activities being conducted on the 1B and 1J well pads, Caerus believes Remediation Projects REM #s 3908, 3807, and Rem 4500 were conducted at the same time, on the same location and therefore should be closed by the COGCC and a no further action determination should be assigned to the project.
