<p>COGCC Inspection Report Summary</p> <p>On 4-14-2021 at approximately 1320hrs , I, Robbie Revas conducted an inspection of KPK well</p> <p>Amaco-Charter-Schneider #7 API # 05-123-07958 in Weld County Colorado.</p> <p>The purpose of this inspection was to confirm compliance with the COGCC Director's order under rule 901.a. of the Rules and Regulations of the Colorado Oil and Gas Conservation Commission, 2 CCR 404-1 ("Rule" or "Rules"). As part of this order the operator KPK (Operator No. 46290) was ordered to immediately suspend all production operations at these assigned location.</p> <p>I inspected this location and confirmed operations appeared to be suspended as equipment on site does appear to be shut off and valves appear to be closed. See attached photos in attachments of this inspection.</p> <p>On 4-14-2021 the operator KPK notified COGCC staff Jeremy Ferrin through email that all 87 locations listed in the order had suspended all production operations at these locations.
