Form 6(s) #400225890 states well was PA 10/10/2011; pursuant with Rule 1004.a, final reclamation activities required to be completed 10/10/2012.

Inspection #675001780 observed that Location has not been reclaimed in accordance with 1004 Rules; Inspection required Operator to comply with 1004 Rules.

It was observed in this inspection that the Location remains out of compliance with COGCC Rules and corrective actions. Final reclamation has not been performed in accordance with 1004 Rules; production equipment has been removed from the Location; large areas of the site remain bare and graveled; compaction issues observed.

Corrective Action:

Corrective action from Inspection #675001780 has not been addressed and remains applicable:

Comply with 1004 Rules; conduct reclamation activities including, but not limited to, removal of gravel, conduct compaction alleviation (cross-ripping to a minimum depth of 18 inches) and revegetation activities. Ensure control measures are implemented to stabilize the seeded soils and that sufficient on-going weed management activities is conducted to keep Location free of species considered undesirable and noxious.

A CA date of 1/17/2019 is being provided as this was the date of the inspection in which compliance issues were was documented, and work required.
