 On Tuesday 4/6/2021 at approximately 1200, I, Inspector Scott Ramsey, conducted a routine inspection at TEP W-14-34, at Location # 334989 in Garfield county Colorado.
 While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat and Wildlife Management Area. Also within close proximity to 317.B. area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for tracking pad.
 During this inspection the following possible compliance issues were observed:
 1. Location show signs of lack of stabilization/compaction
 2. Unused equipment (chemical tank at well heads)
 Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
