A Form 10 Change of Operator was submitted through the API for the KOCHERT 12-18 Well . The associated centralized facility is permitted separately (Loc ID 445805) and also served the KOCHERT 11-18 Well (Loc ID 310649). The site was accessed via a preexisting crop divide road that remains for its historical purpose; all portions of the disturbance specific to the KOCHERT 12-18 Well have been fully reclaimed and returned to cropland. Please see the attached report for additional reclamation activities, details on the completed vegetation assessment, and photo documentation.
