A Form 10 Change of Operator was submitted through the API for the GEMINI K 1-10 well. The site was accessed via a preexisting agricultural and irrigation ditch maintenance road that branched east to the well. The maintenance road remains for its historic purpose. All portions of the disturbance specific to the GEMINI K 1-10 well have been fully reclaimed and returned to cropland. The centralized facility is permitted separately (Loc. ID 450484) and remains active servicing four (4) producing wells: GEMINI K FEDERAL # 01-99HZ, GEMINI G FEDERAL # 06-33, GEMINI K FEDERAL # 01-99HZ, and GEMINI G FEDERAL # 06-33. Please see the attached report for additional details on the completed vegetation assessment and photo documentation of the GEMINI K 1-10 well site.
