- 1) Debris on location. Photos 1, 2, 7, 8. Complete by 1-12-2021.
- 2) Chemical label illegible. Photo 11. Complete by 6-13-2021.
- 3) Gaps / hole in tank secondary containment. Photo 10. Complete by 5-13-2021.
- 4) Gas leak at well. Photos 3 & 4. Complete by 4-13-2021.
- 5) Erosion channels coming off location. Photos 12. Complete by 6-13-2021.
- 6) Production history not current.

Additional compliance issues:

- 1) No battery sign present. Photos 9 & 13. Complete by 6-15-2021.

Note: The emergency phone 800-209-9762 was called on 4-12-2021 @ 16:15 and 4-15-2021 @ 9:33 to report the gas leak. A call back to the inspector was request. No call back occurred from the operator. In the 2 days between inspections the maximum distance of leak detection sound reduced from 100+ yards away to 30 yards.

Location is within a Rule 1202.d Mule deer severe winter range area, and Rule 1202.d, Mule deer winter concentration area, and Rule 309.e.1 Greater sage grouse general habitat management area.
