OPERATOR COMMENTS:

This area noted on the Form 19 was walked and soil was probed with a shovel to identify any notable impacts and assure that representative samples were collected initially on 6/1/2015. No hydrocarbon odors were observed. Minor salt staining was observed. The SS1, SS3, SS4 and SS5 sample locations were re-sampled on 7/13/18 for SAR and EC (SS1, SS3, SS4 and SS5) and arsenic (SS1). The SS1 sample location was resampled for EC on 4/1/21 and the SS2 and SS4 locations were resampled for SAR and EC on 4/1/21. All samples are now within the COGCC Table 910-1 allowable concentrations. Chevron is requesting closure of Spill Release Point 440659 under Table 910-1 due to the initial release occurring during Table 910-1 rule. Samples were collected prior to the Table 915 adoption.
