INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In June 2017, a dump line with a corrosion hole was encountered while excavating a surface stain at the Thompson 13-33 tank battery facility. The volume of the release is unknown. The petroleum hydrocarbon impacted soil was excavated.

In August 2017, groundwater with petroleum hydrocarbon impacts were encountered while removing the partially-buried produced water sump. The groundwater sample exceedance was associated with the June 2017 dump line corrosion hole release.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Between June 26 and 29, 2017, 9 soil samples were collected from the excavation for laboratory analysis of total petroleum hydrocarbons (TPH), benzene, toluene, ethylbenzene, and total xylenes (BTEX), pH, and specific conductivity (EC). Analytical results indicated that BTEX, TPH, pH, and EC levels were in full compliance with Colorado Oil and Gas Conservation Commission (COGCC) Table 910-1 allowable levels at the lateral extent of the excavation.

In August 2017, soil sampling was conducted to determine if petroleum hydrocarbon impacts to subsurface soil resulted from operating a partially-buried produced water sump at the site. Soil samples were collected for BTEX, TPH, pH, and EC analysis. Laboratory analytical results indicated that BTEX, TPH, pH, and EC levels were in full compliance with COGCC Table 910-1 allowable levels at the lateral extent of the excavation. For additional details, please refer to the Sump Closure Report submitted to the COGCC on January 22, 2018.

Proposed Groundwater Sampling

☒ Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

On June 26, 2017, groundwater sample GW01 was collected from the excavation and submitted for laboratory analysis of BTEX. Laboratory analytical results indicated that benzene exceeded the COGCC Table 910-1 allowable level at a concentration of 1,320 micrograms per liter (µg/L). On June 30, 2017, following removal of impacted groundwater from the excavation, sample GW02 was collected for BTEX analysis. Laboratory analytical results for GW02 indicated that benzene exceeded the COGCC allowable level at a concentration of 16.4 µg/L. The groundwater analytical results are summarized on Table 1.

In August 2017, a groundwater sample was collected from the sump excavation which exceeded the COGCC Table 910-1 allowable level for benzene. The exceedance was determined to be associated with the June 2017 dump line corrosion hole release. For additional details of the sump excavation and analytical results, please refer to the Sump Closure Report submitted to the COGCC on January 22, 2018.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

In June 2017, approximately 110 cubic yards of petroleum hydrocarbon impacted soil were excavated and transported to Buffalo Ridge Landfill in Keenesburg, Colorado, for disposal. The impacted soil was excavated into the capillary and phreatic zones to address potential hydrocarbon impacts that may have been present below the current groundwater table due to seasonal fluctuations. Based on excavation groundwater samples exceeding COGCC Table 910-1 allowable levels, approximately 150 barrels of impacted groundwater were removed from the excavation using a vacuum truck and transported to the Aggregate Recycle Facility in Weld County, Colorado.

In August 2017, petroleum hydrocarbon impacted soil was not encountered in the partially-buried produced water sump excavation. The general site layout and excavation footprint are depicted on the Site Map provided as Figure 1.

While backfilling the June 2017 excavation, 100 pounds of COGAC®, a carbon-based bioremediation product designed to capture and degrade petroleum hydrocarbons via chemical oxidation and passive bio-stimulation, were applied to the clean backfill in a series of lifts in the capillary and phreatic horizons.

GROUNDWATER MONITORING

Groundwater monitoring wells MW01 through MW08 are sampled on a quarterly basis. The groundwater samples were submitted for BTEX by United States Environmental Protection Agency Method 8260D through the December 2020 monitoring event. Per the January 15, 2021 rule changes, groundwater samples were submitted for the full list of analytes for groundwater in Table 915-1 as of the March 2021 monitoring event. Cross-gradient and historically compliant groundwater monitoring well MW05 was established as a representative background sample for calculating the inorganic parameters in Table 915-1. The monitoring well locations are depicted on Figure 1. The Groundwater Elevation Contour Map generated using the March 2021 survey data is provided as Figure 2. The groundwater analytical results are summarized in Table 1, and the laboratory analytical reports for the September 2020, December 2020, and March 2021 groundwater monitoring events are attached.

Groundwater monitoring will continue on a quarterly basis until a No Further Action status request is warranted.
