A Form 10 Change of Operator was submitted through the API for the MOSSBERG PMJ 30-10 Well. The associated centralized facility is permitted separately (Loc ID 466294) and also served the MOSSBERG-PM # J30-9 Well (Loc ID 327001). The site was accessed via a 2-track lease road that extended from the northwest corner of the associated tank battery pad. The access road and all disturbance areas associated with the MOSSBERG PMJ 30-10 Well have been fully reclaimed and returned to cropland. Any residual 2-track disturbances at the field perimeter are the result of landowner agricultural operations and not affiliated with the well pad.
