 Field Inspector Actions:  
 On 4-23-2021, I Jason E. Gomez area field inspection supervisor responded to a complaint received by COGCC staff in reference to odor and noise. The complainants stated the Issues were affecting their neighborhood to the south of the locations

I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any odors in or around location. IThe operator was contacted and we requested the third party sound studies from the location to review at the times of the complaints. At time of inspection of the Papa Jo the operator was conducting snubbing operations on location. I spoke to the company man on location Justin Meixsell who indicated they add just begun drill out operations on location utilizing a closed loop system. He also indicated normal operations on location during the times of the complaints. I advised the operator to continue street sweeping and continued inspections of vehicle tracking pad. Weather at time of inspection conditions: Clear-muddy
