It was observed in this inspection that control measures to stabilize the production area, and to prevent off-site sediment transport during wet conditions are missing or insufficient.

**Corrective Action:** Comply with Rule 1002.f.(2)C and install required stormwater and erosion control BMPs; ensure control measures are adequate for the site's conditions, installed in accordance with good engineering practices, and are maintained in a proper functioning condition.
