Comment: Inspection #696202352 observed that stormwater and erosion control measures on the Location were missing, or insufficient. Operator was required to comply with Rule 1002.f.

It was observed in this inspection that Operator has implemented Erosion Logs on the Location. No other control measures appear to have been implemented in conjunction with the logs.

It is unclear if BMPs are adequate for the Location; a followup inspection will be conducted to determine compliance with stormwater rules.
