

Surface Owner Release

This Surface Owner Release is made and entered into this 26 day of Dec, 2013, by Surface Owner, Young Brothers, LLC whose address is 12449 58 Road, Collbran, CO 81624 to Black Hills Plateau Production (BHPP), 1515 Wynkoop St., Suite 500, Denver, CO 80202.

In consideration of BHPP's plugging and abandoning the Kathlyn Young #4-15 and Kathlyn Young #1-15 wells located in T10S – R95W Sec. 15: NWSE and T10S – R95W Sec. 15: NWSW, Mesa County, CO respectively and in accordance with regulations prescribed by the Colorado Oil and Gas Conservation Commission (COGCC), and except for BHPP plugging and abandoning these wells the Surface Owner has requested that BHPP leave the Well Sites in their current condition without performing any reclamation of the Well Sites and Access Roads to the wells as may be required the COGCC rules. The benefit to Surface Owner is the ability to use the Well Sites and the Access Roads in their current condition for their own uses. Accordingly, the Surface Owner hereby agrees that following the completion of its operation to plug and abandon the above mentioned wells, (i) BHPP is to leave the Well Sites and the Access Roads in their current condition without conducting any reclamation of the Well Sites or the Access Roads and (ii) waives any obligation of BHPP to reclaim any portion of the Well Sites or access roads now or at any time in the future, including any obligations that may exist in the rules of the COGCC. Surface Owner agrees and accepts full responsibility for any reclamation that may be required with respect to the Well Sites or Access Roads.

This Release is signed by the Surface Owner as of the date first stated above, but effective for all purposes as of the date the plugging and abandonment operations were completed BHPP.

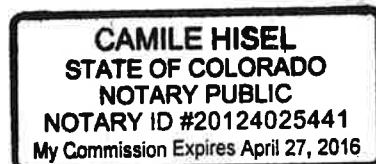
