This well is shut in/TA due to Kerr McGee shutting in their Third Creek gathering system. We are looking into other options to be able to produce this well in a economic way. MIT was performed on 12/28/18 and form 21 (doc# 401962920) was submitted to the COGCC and approved. The well is isolated and all surface valves are closed. Our pumper checks this location 2 times every week to insure there are no surface leaks and the valves are closed.
