 Field Inspector Actions:  
 On 4-26-2021, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Annette Lombardo 1616 Della Court Erie CO stated the issues were occurring outside of complainants home.  
 On 4-28-2021, I attempted to make contact with the complainant who indicated that on 4-22-2021 experiencing a extremely loud noise during night time hours. Also stated it was a constant continuous loud mechanical noise.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual noise in or around location. Third party sound data is attached to complaint inspection document.
