The associated centralized facility is permitted separately (Location ID: 450387). The production facility has been reclaimed and a Form 4 will be submitted separately. The location was accessed via a crop divide road that branches west to the well site. This road remains for its historical purpose of field access. A portion of the access road specific to the Steinmetz 21-17 well has been superseded by the M&M Excavation Yard. The remainder of the road has been fully reclaimed and returned to cropland.
