INITIAL ACTION SUMMARY

Foundation is planning to document conditions beneath all equipment at the Fonte 03-27 well location (ID:303746) through observation and field screening when equipment is removed. Photos will be taken during removal of equipment and submitted on a Supplemental Form 27. Based on observations of staining or odor, Foundation will collect a minimum of one (1) soil sample from the area beneath each piece of equipment on location -- 1 wellhead and 1 produced water tank.

A minimum of two (2) soil samples will be collected as part of the facility closure investigation, collected after each piece of equipment is removed from the location. The samples will be collected at a depth of 6" below surface from areas showing the highest degree of impact (if apparent impacts are present), or from the areas outlined in COGCC's Rule 911.A.(4) Operator Guidance. A background sample will also be collected. If no indication of a release is present, samples will be analyzed for pH, SAR, EC, boron, naphthalene, 1,2,3 and 1,2,4 trimethylbenzene. If a release is discovered, samples will be analyzed for full COGCC Table 915-1.
