## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of two above ground storage tanks (ASTs) at the HSR-Sharkey 8-34. The westernmost AST will be permanently removed, and the easternmost AST will be replaced. In accordance with COGCC Rule 911.a., soil samples and a groundwater sample (if present) will be collected following removal of the ASTs to determine if soil and groundwater (if present) meet the concentration levels of COGCC Table 915-1. Field screening of soils will be conducted during equipment removal activities. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Following the removal of the ASTs, discrete grab soil samples will be collected from beneath each AST and any ancillary piping. The soil samples will be field screened for total volatile organic compounds using a photoionization detector (PID). Soil samples collected following the removal of the ASTs will be submitted (as applicable) for laboratory analysis in accordance with the COGCC Operator Guidance Rule 911.a.(4). Soil samples that are submitted for laboratory analysis will be run for the full list of analytes for soil in Table 915-1. The proposed soil screening and sampling locations are depicted on Figure 2.

### Proposed Groundwater Sampling

If groundwater is encountered during AST removal activities, a minimum of one grab sample will be collected from the excavation (if present) as soon as practical and submitted for laboratory analysis of the full list of analytes for groundwater in Table 915-1.
