**General Comment:**

On 4/22/2021 Catherine Roy conducted a followup reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

- Corrective action to control weeds from 2019 inspection is not addressed. Multiple inspections to control weeds have been issued. Original corrective action date is 7/31/2017. Corrective action date is not applied here as it is the expectation that the weed infestation be addressed immediately to avoid or reduce potential penalties. Multiple control methods beyond herbicide treatment (ie: mechanical) control are needed.
- 2019 FIR Resolution Form documents operator's response to corrective actions related to weeds and stormwater erosion. However weed infestation continues uncontrolled as previous treatment(s) were not adequate.
