On Thursday 5/6/2021 at approximately 1100, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP GGU 1-31, at Location # 323971 in Garfield county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat and Wildlife Management Area. Also location is within or in close proximity to the 411 water protection area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad, there is no evidence of a tracking pad at time of inspection.

During this inspection the following new compliance issues were observed:

1. Access road show signs of lack of stabilization/compaction
