**General Comment:**

On 3/31/2021, Reclamation Specialist Trujillo conducted a final reclamation and stormwater inspection at SG Interests' Volk 12-89-21 #1 location in Gunnison County, Colorado.

This inspection isa followup to inspection:

#696201320 dated 5/26/2020,

#696201669 dated 8/31/2020,

#696202023 dated 11/19/2020

and #696202524 dated 3/31/2021 to document compliance with the following corrective actions:

1002.f.(2)C: Install or repair required BMPs in accordance with good engineering practices and conduct revegetation/reseeding activities by 6/11/2020.

It was observed in this inspection that the Location remains out of compliance with COGCC Rules and corrective actions. However, Operator was onsite at time of inspection, and work to address stormwater and reclamation compliance issues was observed to be in process.

**Comment:** Previous inspection observed that stormwater and erosion control measures on the Location were insufficient, or missing in accordance with Rule 1002.f.(2)C. Inspections required Operator to comply with Rule 1002.f.(2)C by 6/11/2020.

It was observed in this inspection that though the Location remains out of compliance with COGCC 1002.f. Stormwater Rules, Operator was onsite at time of inspection, and work to address the stormwater and reclamation compliance issues was observed to be in process.

Original CA and date will remain applicable until work has been completed to address the CA in its entirety, and a followup inspection is conducted to determine compliance with stormwater Rules.

**Corrective Action:** Install or repair required BMPs in accordance with good engineering practices per Rule 1002.f.(2)C. Conduct revegetation/reseeding activities on the slopes and install erosion controls to stabilize the seeded soil.
