The extent of impacted soil will be determined by field screening and collecting confirmation soil samples during excavation to confirm concentration levels are below COGCC Table 915-1 standards. Upon delineation and excavation of the impacted soils, the excavation will be backfilled with clean fill. KTM will mobilize a crew to complete excavation and delineation within 30 days. A supplemental Form 27 with closure sample results, final excavation extent, and NFA request will be submitted within 60 days of the completion of field work and receipt of laboratory analytical.
