Comment: Renegade once again requests that the operator contact list on file be made to reflect previous filed lists submitted electronically. Numerous requests have been made after past COGCC inspections but the contact list still doesn't reflect those requests.
No request to vent or flare for the State P#1 is required as no gas production is being produced from this SI well. Form 4 requests to vent or flare have been made for the State P#2 (Doc. no. 402125915), State P#3 (Doc. no. 402126102) and State P#4 (Doc. no. 402126155) and approved in May of 2020. All four wells utilize a common tank battery. The State P#1 has been SI since the shut down of the Third Creek gas gathering system in May of 2018.
