On Wednesday 5/12/2021 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus RE 2, at Location # 334571 in Garfield county Colorado.  
While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat and Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.  
During this inspection the following possible compliance issues were observed:  
1. No tank battery signage  
2. Random debris around well heads  
3. Braden head had fluid around it on the ground and was bubbling  
Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
