#### COMMENTS:

As a result of the Form 17 bradenhead test performed on 12/29/2020 (Document ID: 402567945), Crestone Peak has added the Kugel 21-18 well to our monthly bradenhead blowdown schedule, due to bradenhead pressure greater than 50 psi. The well is being blown down to 0 psi through our bradenhead test trailer. At the end of the data collection period, Crestone will propose further plans, as needed, to the Commission via Form 4 Sundry. While Crestone has calculated the blowdown emissions for the events and found them to be deminimis, all emissions are permitted under the new CDPHE regs. Crestone will analyze the data and work with the state engineer to implement BACT.
