INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the closure of two separators at the Badding 1C, 26N, 16C-26HZ O Facility. Of the two separators to be removed, the northernmost separator will be permanently removed, and the southernmost will be replaced, as depicted on Figure 2. In accordance with COGCC Rule 911.a., soil samples and a groundwater sample (if present) will be collected following removal of the two separators to determine if soil and groundwater (if present) meet the concentration levels of COGCC Table 915-1. Field screening of soils will be conducted during equipment removal activities. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Following the separator removal operations, discrete grab soil samples will be collected from beneath the two separators and associated piping. The soil samples will be field screened for total volatile organic compounds using a photoionization detector (PID). Soil samples collected following the removal of the equipment will be submitted (as applicable) for laboratory analysis in accordance with the COGCC Operator Guidance Rule 911.a.(4). Soil samples that are submitted for laboratory analysis will be run for the full list of analytes for soil in Table 915-1. The proposed soil screening and sampling locations are depicted on Figure 2.

Proposed Groundwater Sampling
