3. TIH with CIBP. Set BP at 6470'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Nioa perms @ 6672')
4. TIH with CIBP. Set BP at 4200'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Sussex @ 4250')
5. TIH with CIBP. Set BP at 2500'. Top with 2 sxs 15.8#/gal CI G cement.
6. TIH with tubing to 1480'. RU cementing company. Mix and pump 113 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
